- 5). This application is made pursuant to the authority of *People v. Bachert*, 133 AD2d 482 (A.D. 3 Dept. 1987).
- 6). Petitioner was represented on direct appeal by Edward V. Sapone, located at 40 Fulton Street (23rd Floor), New York, New York 10038.

- 7). Petitioner's direct appeal was heard and disposed of by this Court on October 6, 2016. People v. Santos, 143 AD3d 479 (A.D. 1 Dept. 2016).
- 8). Petitioner did not file an application for leave to appeal to the New York Court of Appeals.
- 9). For the reasons stated within petitioner's writ of error coram nobis and the attached memorandum of law, petitioner urges this Court to grant the relief sought.

CONCLUSION

For all of the above stated reasons, including those stated within the attached memorandum of law, petitioner, Miguel De Los Santos, urges this Court to grant the relief sought; and for any other or further relief as this Court may deem just and proper.
